<u>Major Parkway Lift Station Rehabilitation Project</u> - An application and certificate for payment in the amount of \$118,093.51 was submitted for approval.

RESOLVED, that the application and certificate for payment be approved.

The motion was unanimously carried.

<u>Sixth Street Lift Station</u> – Requested approval of \$1157.00 to purchases deodorizers.

RESOLVED, that the request be approved.

The motion was unanimously carried.

<u>Major Subdivision Drainage</u> – Mr. Langlois reported that he is researching a solution to the drainage issues in the subdivision.

Resolution – Authorizing the City of New Roads to enter into an intergovernmental contract and local services agreement with Fire Protection District Number 5 of the Parish of Pointe Coupee so as to enable the city to improve its fire hydrants
