## **H. Patrick Witty – P.C. Young Leaders Scholarship Program**

In Mr. Witty's absence, Mr. Kellerman and Mr. White presented the information on the scholarship program.

The Pointe Coupee Young Leaders (PCYL) Program was first implemented in 2001 as an opportunity to help the students of Pointe Coupee Parish develop into strong and impactful leaders. The Leadership Program facilitates interaction between program participants and community leaders, demonstrates the value of diversity through collaboration, provides an in depth look at the key roles that government and business play in our parish and offers participants tools to help them grow in leadership and service.

This scholarship is given in honor of Bertell J. Dixon to a high school senior (PCYL participant) that has displayed outstanding leadership qualities and a willingness to serve. Bertell, one of the founders of the Pointe Coupee Young Leaders Program, a Pointe Coupee native, public servant and family man continually gave back: to his family, his church and his parish. From the start of PCYL, Bertell's greatest hope was for Pointe Coupee student's experiencing the joy that can be derived from education, meaningful work and service to others.

Donations are tax deductible and checks are to be made payable to the Greater Pointe Coupee Chamber of Commerce with a note to earmark the dollars for the Bertell J. Dixon Memorial Scholarship.
